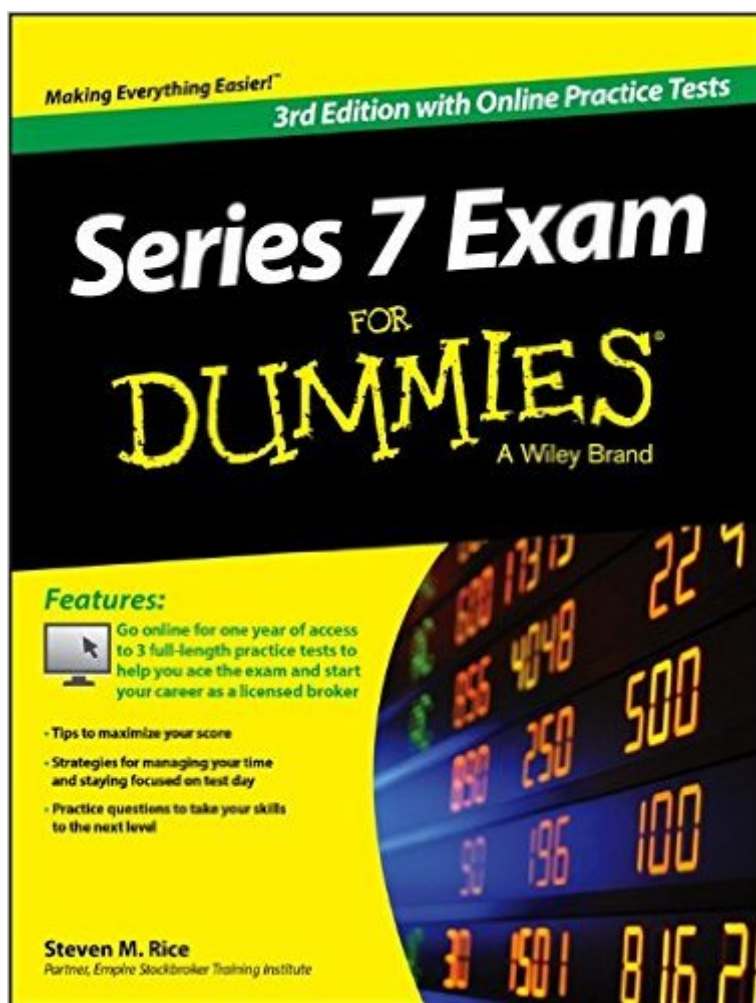

I usually don't write reviews very often but I must say that this book did break up the concepts and

the questions in a very easy to follow way. Once you understand how the "Dummies" format works you can really understand the questions. If that is not enough, my friend told me to memorize the questions and you should do well, I laughed but it worked for him.

If I recently picked up the "PHR/SPHR Exam for Dummies", then the "Series 7 Exam for Dummies" was for me because I'd never heard of it. I wanted to know what this exam was about and I like the "For Dummies" line because I like the way the books are a bit of a short course to bringing someone up to speed on what something is and author Steven M. Rice does a great job of it for this exam for selling securities. As it states in Chapter 1, passing the exam "qualifies you to hold the title General Securities Registered Representative (stockbroker)"...I like that right away, the author notes that the book is meant as a supplement to classes and textbooks. For someone like me, it is useful as a primer to find out if this is something that I'd be interested in and whoa, given the amount of information packed into this book, I would honestly say, "No, I'm not cut out to be a stockbroker if this is just a supplemental book," because there is a lot of information. For those who are serious about the field, the author does not skimp on subject range and along with the practice exam, there is a one year of online access to three more practice exams. The author also goes into strategies on how to best prepare for the exam. It was a very interesting read for someone like me. It opened my eyes on what stockbrokers have to view and absorb. I think the book is useful for those who are preparing if used as an intended supplement.

The "Dummies" team has done it again. This book is chock full of information presented in an easy-to-understand format. The questions and explanations alone are more than worth the price of the book.

This is an exam preparation book, not a course material review book. As an exam prep book, it does the job. The book contains information on resources for course materials and classes for those looking for that.

This book is a guide full of practice exams for the Series 7 exam, which allows a sponsored party to trade financial instruments, such as stocks. The book is intended to give sufficiency to be able to prepare for this exam. Similar to the exam format, the questions break down the particular exam categories, such as qualifying, financial instruments and the like in similarity of the exam. The book is a fine guide. I have looked through it variety of times, though admittedly not used it to study for the

exam because under FINRA rules, the exam taker must be sponsored by a trading organization. However, it is evident that the book is a good source for the exam taker with a variety of questions to aid in study. I have used the book for personal enrichment as I am a regular consumer of financial information and this is an interesting challenge to test my knowledge.

I have taken the Series 7 several times and find that the best preparation is in exam questions. Exam questions help you understand what the tester will be looking for and how to answer. This is an excellent book for prepping for the exam. It does not have all of the theory and other material, but it will give you a very good idea of what you need to know and the kind of answers you should provide. Highly recommended to pass the Series 7.

This is definitely one of the best Dummies test preparation books you'll find. Everything is clearly explained in a detailed manner. Of all the guide books out there, this is easiest to understand and benefit from. I heavily recommend this to everyone who's anticipating these tests.

This is an excellent text for those preparing for the test of course, but even if you are not planning on that career progression it is a terrific guide for regular investors too. Lots of questions answered so perhaps it can even save you a trip to a professional.
